## Vehicle Registration Form and Gate Use Agreement

The Association hereby issues a gate access remote control transmitter to control the Association's Entrance Gate located at Heron Lakes Drive and Gessner Street, Houston, Texas, subject to any rules and regulations of the Heron Lakes Estates Owners Association, Inc., which are made a part hereof, and further specifically subject to the following rules:

1. Individual certifies that the person named below is a resident of the Heron Lakes Estates subdivision; that Resident and family will be the only persons using the gate remote transmitters, and that non-residents of Heron Lakes Estates subdivision will not be allowed to use the gate remote transmitters.
2. Resident shall hold harmless and indemnify Heron Lakes Estates from any and all liability, causes of action, damages, costs, attorney fees, and any other matter or cost whatsoever arising, or asserted as arising, out of, or incidental to, use of the Heron Lakes Estates entrance and/or exit gates. Resident shall be personally liable for and shall pay upon demand any and all damages to the Heron Lakes Estates entrance and/or exit gates.
3. Resident shall not permit, and shall promptly report to the association and law enforcement officers, any unlawful activity occurring during or incidental to Resident's use of the Heron Lakes Estates entrance and/or exit gates.
4. There will be a charge of: \$50.00 per remote transmitter. These charges will also apply to replace lost or stolen access control units. These charges are non-refundable and the remote transmitters are non-returnable and non-transferable.
